

Dear Sirs:-


Pursuant to the request of Gurdit Singh, I beg to advise you that I will accept \$60.00 in full satisfaction of all claims ^{for bills} rendered against the Society to date. This more particularly in view of the fact that so far as the Burial requirements are concerned we have not been very successful. I make this moreover on the statement of Mr. Gurdit Singh that I am hereafter to get all the legal work coming through the Khalsa Diwan Society. I will, in all cases, do my best to prevent litigation among your people or obtain settlements and urge settlement by the parties among themselves. As to the work of the Society itself, I will be prepared, in case the Society has to pay the account themselves and have no chance of re-couping themselves out of the clients for whom I may act, ^{and they recommend} agree to accept 75% of the amount of the account and discharge the Khalsa Diwan Society thereout.
