

THIS AGREEMENT made in duplicate this 27th day of February 1922, A.D..

BETWEEN

THE TANSOR LUMBER COMPANY LIMITED of the City of Duncan in the Province of British Columbia, of the one part.

-and-

THE DEERHOLME LUMBER COMPANY LIMITED of the same place aforesaid, of the other part.

WHEREAS an agreement has been entered into by The Deerholme Lumber Company Limited with the Tansor Lumber Company Limited for the purchase of an EDGER size- 5" X 42". Made *by Hill and Curtis Co.*

Now THIS AGREEMENT WITNESSETH:

1. The purchase price of this edger is three hundred \$300.00 dollars. \$100.00 is to be paid in cash, (The receipt of which is hereby acknowledged by the Tansor Lumber Company Limited), and the balance is to be paid by monthly payments of \$25.00 each month. The first payment of \$25.00 is due on the 27th day of March, and shall be paid by the Deerholme Lumber Company Limited on time, and on the 27th day of each and every succeeding month a further sum of \$25.00 shall be paid until the total amount of \$300.00 shall have been paid by the Deerholme Lumber Company Limited.
2. It is agreed that the time shall be the essence of this agreement and should any payment be delayed it is agreed that after a notice of 5 days have been given by the Tansor Lumber Company Limited this agreement may be terminated and that the ~~party or parties~~ Tansor Lumber Company Ltd. has the right to take back this edger and if necessary has the right to enter the premises of the Deerholme Lumber Company Ltd. to take possession of the said edger. In such a case it is agreed that all previous payments are to be forfeited.
